

**PetSafe® Pet Super Fan Photo Sweepstakes
Official Sweepstakes Rules**

By entering the Sweepstakes you accept and agree to be bound by these Official Sweepstakes Rules.

No Purchase Necessary:

No purchase necessary to enter. A purchase will not increase your chances of winning. Void where prohibited by law.

2. Sponsor:

The PetSafe Pet Super Fan Photo Sweepstakes (the “**Sweepstakes**”) is sponsored by Radio Systems Corporation having a principal place of business at 10427 PetSafe Way, Knoxville, TN 37932 (the “**Sponsor**”).

3. Prize Description:

During the Sweepstakes, Sponsor will award one (1) Prize in accordance with these Official Sweepstakes Rules. The Prize Winner will be awarded one (1) PetSafe® Brand containment system of the winner’s choosing. The total value of each Prize to be awarded is less than Four Hundred Dollars (\$400.00).

4. Eligibility:

The Sweepstakes is open only to legal residents of the United States who have reached the age of majority at the time of entry, an “**Entrant**.” Employees, officers, directors, affiliates, licensees, distributors and fulfillment agencies of the Sponsor, and respective immediate family members (a spouse, sibling, parent, child or grandparent and the spouses of such persons) and other persons living in their same households are not eligible to participate in the Sweepstakes.

5. Sweepstakes Entry Period:

The Sweepstakes begins at 8:00am ET on September 19, 2016, and ends at 11:59pm ET on September 26, 2016.

6. How to Play / Description of Sweepstakes:

a. Entry

To enter the Sweepstakes, an Entrant must visit the Sponsor’s designated website and complete the entry form and photo submission contained therein.

Each Entrant represents and warrants that the photo submitted and caption provided:

- (i) Is original and was lawfully produced by the Entrant; and
- (ii) Does not infringe the intellectual property rights or privacy of any third party.

All Entries must be received by the Sponsor before 11:59 pm ET on September 26, 2016. One Entry is allowed per person. Entrants may not enter the Sweepstakes using multiple addresses, emails or identities nor may entrants use any other device or artifice to register multiple times or as multiple parties. Any Entrant who attempts to enter with multiple identities or uses any device, false identity or artifice to enter multiple times will automatically be disqualified from the Sweepstakes. Any Entry that is illegible, inaccurate, incomplete, late or does not otherwise conform with these Official Sweepstakes Rules will be disqualified. Sponsor is not responsible for late or incomplete Entries or for technical problems with the

photo submission. Entrant is solely responsible for all electronic submissions, and Sponsor will not be responsible for any submission that is not received due to an incomplete or improper transmission or other technical problems. Sponsor has no obligation to correspond with any Entrant or acknowledge the receipt of any Entry. Sponsor has no obligation to advise Entrant of an incomplete Entry, and any Entry that is incomplete will be disqualified.

b. Winner Selection.

Winners of the Sweepstakes will be selected by a random drawing conducted by the Sponsor, or an authorized agent of the Sponsor, held on the following business day. The Prize drawing will be made from all eligible Entries received as of the drawing date. Odds of becoming a Winner depend on the number of eligible Entries received in the Sweepstakes. Sponsor will notify period Winner within 72 hours of the drawing. If the Winner fails to comply with these Official Sweepstakes Rules, or is ineligible to receive a Prize, the Prize will be awarded to an alternate party selected by a second random drawing conducted in accordance with these Official Sweepstakes Rules. The Sponsor shall not be responsible or liable for failure to contact a potential Prize Winner who provides incorrect or incomplete contact information or does not respond within one (1) week from the notification date. All Winners may be required to submit valid identification to the Sponsor to claim a Prize.

c. Award of Prizes.

Prizes will be awarded within thirty (30) days following verification of eligibility and compliance with the terms of these Official Sweepstakes Rules. If required by Sponsor, all Prize Winners must sign and return a release of liability form and declaration of eligibility to receive the Prize. The Sponsor's decisions regarding the selection of winners and all other aspects of the Sweepstakes shall be final and binding in all respects. The Sponsor will not be responsible for typographical, printing or other inadvertent errors in these Official Sweepstakes Rules or in other materials related to the Sweepstakes.
